

Please note: To be eligible to access our funding portal you must be a VCSE organisation working in



the City of Manchester with at least 50% of your beneficiaries in the City of Manchester. VCSE organisations working outside of the City of Manchester, consultants, sole traders, statutory bodies, private businesses and infrastructure organisations who become members of Macc aren't eligible to access our funding portal. #### #iWill 2019

**Aims/priorities:** #iwill is a UK-wide campaign that aims to make social action part of life for as many 10 to 20 year-olds as possible



by the year 2020. Through collaboration and partnership it is spreading the word about the benefits of youth social action. The programme aims to increase overall participation of young people in meaningful social action from 40% to 60% by 2020, with a particular focus on deprived areas. Social action involves activities such as campaigning, fundraising and volunteering and has huge potential to create enjoyable opportunities and skills development for young people, and in turn benefit the local people and places. Step Up To Serve, Big Lottery Fund and the Government Office for Civil Society have invested £2million this year to fund groups delivering youth social action opportunities. Community Foundations will match this investment. #### **Manchester Wellbeing Fund**

Aims/priorities: In January 2017, Greater Manchester Mental Health NHS Foundation Trust (GMMH) embarked on

an ambitious programme of clinical service transformation to improve the mental health outcomes for people receiving their services and to support the wider mental wellbeing of Manchester citizens. Part of this vision for Manchester services involves building community support to promote mental wellbeing (feeling good and functioning well) and support people living with mental health conditions in the community. A budget of £1.5m has been allocated for the three-year Manchester Wellbeing Fund, for community groups and GMMH service users who have great ideas about how to support their communities. The main objectives of the Fund are:

- to develop community support around people's mental health needs
- to promote mental health and wellbeing
- to challenge the stigma around mental illness

**Who can apply?** The Fund is for groups and service users who are passionate about mental wellbeing in their communities. It is designed to support individual projects rather than provide core funding for organisations.

Grant amount: Grants of between £250 and £3,000 are available

#### **Near Neighbours**

School Parent Teacher Associations can also apply if they have the support of local residents and parents and the project benefits the wider community as well as the school.

Grant amount: Applications should not exceed £10,000

## ARTS

#### Andrew Lloyd Webber Foundation

**Aims/priorities:** The Andrew Lloyd Webber Foundation's principle objectives are to promote the arts, culture and heritage for the public benefit. Funding is available to not-for-profit organisations, including

charities, companies and community trusts, for projects in the areas of culture and the arts that make a real and ongoing difference to people's lives in the UK. Priority will be given to projects that enable people to develop skills and careers in heritage and in all areas of the performing arts (music, dance and drama) but other areas will be considered. For the purposes of funding:

- Real means an appreciable and significant difference. For example, something that affects one person's life to a great extent, possibly leading to a significantly improved probability that the person will be involved in the Arts on an ongoing basis (i.e., by having a career in the Arts) and something that affects many people's lives, (i.e., through improved access to the Arts)
- Difference implies that the funding award contributes to something that would not otherwise happen, without the making of such awards. This might (but need not necessarily) include the overcoming of special difficulties/obstacles
- Ongoing refers to something that is going to have a long-term benefit and an ongoing effect on people's lives, rather than 'an effect that is ephemeral'

**Who can apply?** Not-for-profit organisations, including charities, companies and community trusts, based and operating within the UK, are eligible to apply.

**Grant amount:** Unlock grants up to  $\pounds$ 5,000, Enhance grants up to  $\pounds$ 10,000, Empower grants up to  $\pounds$ 25,000. It is expected that most applicants would have secured a significant proportion of funding prior to sending in their application.

**Application process:** Two stage process. Apply online by completing a short application form outlining your project. The Andrew Lloyd Webber Foundation automatically acknowledge by email and decide whether to take it further within 6 weeks.



The Foundation would normally expect the building to be listed, scheduled, or in the case of a garden included in the English Heritage Register of Parks and Gardens. However, the Foundation also makes grants to projects which involve an unlisted building of sufficient historic or architectural significance or importance, if it is within a conservation area.

**Who can apply?** Applicants can be either an organisation or a private individual, having legal responsibility for the repair of an historic building, its gardens and grounds, in England or Wales. The Foundation would normally expect the applicant to own the building or estate, or hold a full repairing lease with not less than 20 years to run, or be able to demonstrate that the applicant has a legally binding agreement to acquire such a building or estate.

**Grant amount:** The minimum grant that can be applied for is £1,000 and the maximum is £250,000

Deadline: Pre-applications forms can be submitted at any time

Application process: There is a two-stage application process:

- Pre-application forms are available to complete online or download from the Foundation's website.
- If successful, the Foundation will arrange a site visit to make an initial check of the suitability and feasibility of the project prior to completion of the full application form

Applications must be supported by a professional adviser or specialist contractor's report, as well as colour photographs that show the extent and urgency of the project.



The Football Foundation is a UK sports charity which funds the development of grassroots sports facilities in order to improve the quality and experience of grassroots sport and to encourage participation. The funding is intended to establish new youth futsal leagues across England, to increase the opportunity for players to play futsal on a regular basis, within a structured games programme. The funding must be used to establish either one or two new youth futsal leagues. To be considered a League, programmes must:

- Run games on a monthly, weekly or bi-weekly basis
- Deliver at least seven rounds during a playing season
- Be held in appropriate venues using futsal specific equipment
- Contain a minimum of eight teams
- Be affiliated to a County FA and be administered using FA Full Time
- Only use qualified, FA affiliated referees
- Have a named welfare officer
