appropriate regulatory body, such as your nation's Charity Commission or Companies House (unless your organisation currently holds a BBC Children in Need grant). We will not be accepting applications from educational institutions (including schools), prisons, hospitals or other statutory bodies.

Grant amount: Covid-19 2020 Booster Grants Programme for current Children in Need grant-holders grants of up to £5,000 over a 6 month period. Covid-19 Large Grants programme for funding of up to £80,000 over an 18-month period.

Clinks Covid-19 Response Grants

Supporting the voluntary sector working in the criminal justice system

Aims/priorities: The COVID-19 Response Grants

scheme is administered by Clinks on behalf of Her Majesty's Prison and Probation Service (HMPPS) and the Ministry of Justice. The funding is intended to support voluntary organisations who have had to reduce service provision or are adapting their services to deliver vital support to people in the criminal justice system due to the coronavirus/COVID-19 pandemic. The funding is

to be used for activities and resources which help organisations deliver support to people in the criminal justice system during the crisis. For example, this could be additional equipment or a contribution towards a salary.

Who can apply? Applications will be accepted from voluntary organisations with an income of under £500,000 operating in England and Wales, supporting persons in prison, leaving prison or under licence in the community or serving a community sentence in the context of Covid-19.

Grant amount: Grants of between £3,000 to £5,000 are available

The Community Justice Fund

Aims/priorities: The Community Justice Fund has been formed by a partnership of key representative umbrella bodies and a



group of independent funders to help specialist social welfare legal advice organisations to cope with the immediate impact of COVID-19 epidemic and lay the foundations for longer term renewal. The Fund is made up of contributions from a range of sources, including the government, and it's envisaged that funding will be awarded in 2 waves. The first wave, which is now open and will run for 6 months, will provide flexible grants to organisations that meet the eligibility criteria and priorities here. The Fund aims to assess applications on a weekly basis and decisions received within 10 days of an application being submitted.

Who can apply? Registered with the Charity Commission and working in the UK;

AND able to demonstrate a track record of delivering legal advice in one or more of the following areas of law: asylum, community care, debt, disability, discrimination, education, employment, housing, immigration, mental health, public and administrative law and welfare benefits; AND able to demonstrate a track record in delivering advice at specialist level including carrying out end-to-end casework for clients, carrying out representation in a court or tribunal and/or holding legal aid contracts

The fund is not able to support generalist advice agencies, private sector legal aid practices or individuals.

Grant amount: Grants are likely to be between £25,000 - £75,000, but could be larger in certain circumstances

- Are unable to meet an increased demand for food from vulnerable individuals or supporting charities
- Have the capacity to distribute all of the food purchased under this grant by 9 August 2020
 The funding is to be used to provide for people:
 - Who are unable to afford food
 - Who have moved into temporary accommodation as a result of COVID-19, for example those who have left home due to domestic abuse, newly released prisoners, or the newly homeless

Aims/priorities: The Edward Gostling Foundation provides

grants with the aim of enhancing the quality of life for people in need, specifically the mentally and physically disabled or those with long-term illness. The Foundation has suspended accepting applications from charities with a gross income in excess of £5 million and is currently focused on helping smaller charities providing front line community services. This funding can be used to support their core operating costs. Applications must address at least one of the four themes of the Foundation:

- Health and wellbeing: to maintain, improve and advance the health and welfare of people living with disabilities and/or long-term illnesses
- Independent living at home: to support people who wish to remain living in their own home for as long as is practically possible
- Respite: either for the person living with a disability (or long-term illnesses) or the carer to access sports and leisure activities or simply enjoy fun, friendship and the opportunity to socialise and share with others who may be in a similar situation
- Transition: to provide fundamental life skills and infrastructure necessary to allow people to reach their full potential in all areas of life and to become a valued member of their local community

Who can apply? UK charities that have been registered for at least three years.

Grant amount: Up to £10,000 are available to eligible charities with less than six months' of free reserves

bought due to lost wages including:

- Children's bedroom furniture, e.g. beds, bedding, clothes storage furniture (chest of drawers)
- Essential White Goods, e.g. replacing a broken appliance such as fridge/freezer, washing machine. cooker/oven.

 Specialist items for children with additional needs, e.g. sensory toys, adaptive clothing or SEN adapted computers

Depending on the situation, they also offer a number of grants programmes such as:

- Specialist equipment grants

Heritage Emergency Fund

Aims/priorities: The fund is available to organisations across the full breadth of heritage, including historic sites, industrial and maritime heritage, museums, libraries and archives, parks and gardens, landscapes and nature. Priority will be given where:



- there is limited or no access to other sources of support
- where heritage is most at risk

where an organisation is at risk of severe financial crisis due to COVID-19
 Priority within the fund will be given to organisations:

- Managing or caring for at-risk heritage or those working to meet our priority outcomes around economic regeneration, inclusion and wellbeing – as defined within the Strategic Funding Framework
- Working within one or more of the 13 areas of focus identified in the strategic funding framework. These are communities experiencing social deprivation which are central to place-making within these neighbourhoods
- Which are not eligible for or in receipt of other emergency funding either from Government and/or other National Lottery distributors
- Which have limited alternative options of emergency support and are already mitigating risks through other measures e.g. putting projects on hold, rephrasing milestones, repurposing other funding to support day-to-day operations
- Which are at greatest financial risk from coronavirus (COVID-19) due to a reliance on trading or community fundraising income streams
- Are at greatest financial risk due to having limited reserves i.e. less than three months and limited access to the short-term liquidity needed for essential activity

Who can apply? Applicants must be:

- a not-for-profit organisation, and
- a current or previous recipient of a grant directly from us, and
- an owner, manager or representative of heritage, or be able to show you have delivered participatory heritage activity

Hope for the Young – COVID-19 Emergency Fund



Aims/priorities: This charity has set up an emergency relief fund in response to the growing impact of coronavirus/COVID-19, to support young asylum-seekers and refugees during the pandemic. The funding is intended to support the immediate health and well-being of young asylum seekers and refugees during the current crisis, and to help to relieve destitution and poverty in general. Grants can be used to cover essential costs such as:

- Food
- Medicine

- Essential toiletries
- Topping up gas and electric metres
- Pay as you go mobile phone credits and data

Grant payments will be allocated on a case by case basis depending on young people's needs.

For example:

- Regular weekly or monthly payments for food or mobile phone top ups.
- A one off payment to buy a mobile phone to help young people stay connected.

Who can apply? Young asylum seekers or refugees aged 16-30 years old based in the UK who are vulnerable and in need of immediate financial support to help in the relief of social isolation and financial hardship during the Coronaviris pandemic.

Morrisons Foundation – COVID-19 Homeless Support Fund



Aims/priorities: The Morrisons Foundation Trustees is making funds

available through the Homeless Support Fund to support charities caring for the homeless during the coronavirus/COVID-19 outbreak and ensure help gets to those who need it most. The funding is for homeless people who are particularly vulnerable to COVID-19 because they are more likely to have underlying health conditions and are less able to access basic sanitation. For those who are sleeping rough or are in a crowded night shelter, it is impossible to self-isolate and maintain social distance.

Who can apply? Applicants should:

- Be registered with the Commission/OSCR for a minimum of one year and have filed their documents (i.e. trustee's reports and financial accounts) on time
- Work directly with homeless people and provide support of one or more of the areas the fund cover
- Accept payment electronically over the phone (by credit card or BACS)

Registered charities who care for the homeless can apply for support to cover the following broad areas:

- Outreach and support for rough sleepers, including provision of essentials
- Delivery of services in hostels and shelters
- Information and advice

Who can apply? The NSUN grant is for organisations or collectives or groups which may or may not be constituted (but are not set up as a charity or a community interest company (CIC), for example) or who otherwise are not eligible for the main Coronavirus Mental Health Response Fund. You will need to be a member of NSUN.

Grant amount: Grants of up to £1,000 are available (Grants of up to £2,000 may be considered in some instances)

Resilience and Recovery Loan Fund

Aims/priorities: The Resilience and Recovery Loan Fund (RRLF) is a new



fund for social enterprises and charities who are experiencing disruption to their normal business

model as a result of COVID-19. It has been established to make an existing government scheme (the Coronavirus Business Interruption Loan Scheme) more easily accessible to charities and social enterprises. The RRLF is being run by Social Investment Business (SIB) with an initial £25m investment and support from Big Society Capital.

Who can apply? Charities, community interest companies and community benefit societies are eligible for these funds – organisations that are not one of these legal forms (ie just a company limited by guarantee or company limited by shares) will need to demonstrate social objects / purpose in their Articles.
